The Finance Department, Government of Sindh has received a loan from the International Development Association (IDA), World Bank, under the Sindh Public Sector Management Reform Project (SPSMRP), IDA Credit # 5584-PK. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for “Procurement of ITC Equipment for Excise, Taxation and Narcotics Control, Sindh”.
2. The Economic Reform Unit, Finance Department, Government of Sindh as the Project Management Unit of SPSMRP now invites sealed bids from eligible bidders, registered with relevant tax authorities, for the supply of Information Technology and Communication (ICT) equipment for its stakeholders as per details given in the bidding document.
3. The bidders must submit their bids for all the items as mentioned in the bidding document and award shall be on the basis of bidding for all items.
4. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the World Bank Standard Bidding Documents: Procurement of Goods for National Competitive Bidding.
5. The method of procurement shall be under National Competitive Bidding (NCB) procedures specified in the World Bank’s Guidelines: Procurement of Goods, Works and Non-Consulting Services, under IBRD Loans and IDA Credits, January 2011.

7. The bid must be accompanied by a bid security of **2% of the Total Bid Amount**, in the form of Bid Security Bond (bid bond) in favor of Director, Economic Reform Unit, Finance Department, Government of Sindh.
8. Bids must be delivered through any means mentioned in the bidding document, **by 11:00 a.m. on Thursday 14<sup>th</sup> May, 2020.**
9. Bids will be opened as per the procedure mentioned in the bidding document on **Thursday, 14<sup>th</sup> May, 2020 at 12:00 noon.**
10. The bidders are requested to give their best and final prices as no negotiations are expected.
